

ALCOHOL IS NO ORDINARY COMMODITY

Alcohol is the only drug where if you don't do it, people assume you have a problem.



- New Zealand's most harmful drug is alcohol (88)
- Carcinogen cancer and other health issues (1 in 10)
- Estimated 5% of births in New Zealand have FASD
- More than 26% of suicides are related acute alcohol use
- 54% of family violence incidences alcohol/ drugs involved
- 11% admissions to ED are for alcohol issues
- 45% of fatal crashes alcohol or drugs are a factor


Public objections (Community engagement):

- The public are notified about alcohol licence applications either online or in local newspapers, which are posted on proposed locations
- The public have 15 working days to object, in writing, from the first notification of licence application
- The public can only object if they have 'greater interest than the public generally'
- Objectors can only object under statutory grounds (s105 of the Act for new licences and 131 for renewals)
- Objectors may present an evidence brief and call

What do I write in an objection?

There are 11 criteria that DLC must 'have regard to' when considering a licence application:

COMMUNITY VULNERABILITY

"I am concerned that the Applicant has not considered the impact of the proposed store on the vulnerable community."

DENSITY OF ALCOHOL OUTLETS

SENSITIVE SITES

ALCOHOL RELATED HARM

Vandalism, Sound Control, Alcohol Litter - amenity and good order.

CRIME

Crime level in the community and alcohol outlets are prone to ram raids and robberies

OTHER

Staffing Issues, history of misconduct under their licence, Safety and security concerns, located on a highway, selling other products e.g. vape, pokie machines

Trading Hours

Alcohol may be sold on the premises, only on the following days and during the following hours: Monday to Friday, 10.00 am to 6.00pm.

Product Restrictions

No single sales of RTDs, shots, or premixed shots.

No sales of tobacco, cigarettes, vaping products, or products associated with smoking or vaping.

Sale Restrictions

No transactions may take place using Afterpay or similar 'buy now, pay later' payment methods.

Advertising

No bright colours shall be used in the external decoration of the premises.




Alcohol Harm Reduction




